Policies and Terms



Financial Agreements:

Payment of all fees is expected at the time of service or via credit card on file. We will assist you in submitting claims to your insurance carrier.

It is the client's responsibility to check insurance benefits and coverage. You will be responsible for any non-covered services, deductibles, co-payments or co-insurances, as determined by your insurance carrier. Accounts unpaid by the insurance carrier greater than 90 days will be billed to the client.

- Outstanding balances that remain unpaid after 30 days will incur a 10% late fee. An additional 10% late fee will be added for
 each following 30 days the balance remains unpaid. Any outstanding balances after 90 days may be referred to an outside
 collection agency.
- If required by insurance, it is the client's responsibility to bring a proper referral (and/or obtain any required pre-authorization) and copay to the appointment.
- NNDC cannot guarantee insurance coverage for services and it ultimately the client's responsibility to be aware of your insurance coverage, limitation and exclusions before the time of service.
- Out-of-pocket payments can be made via credit/debit card, cash or check and are due on the date of your appointment.
 Credit/debit card payments can be made directly with your Registered Dietitian or through the Healthie portal. Please make checks payable to Nielson Nutrition & Diabetes Care. There is a \$35 fee for all returned checks.
- The client will be responsible to pay a \$40 late cancel fee for any missed or cancelled visits, not made at least 24 hours in advance prior to the scheduled appointment time.
- If the client defaults on their account, they understand that they will be subject to finance and/or legal fees in addition to the total account balance.

Telehealth visit option

NNDC offers telehealth visits through the HIPPA-compliant Healthie platform. These visits will be billed similarly to in-person visits and all agreements in this document further apply to telehealth visits.
